# County seeks public input on shoreline bylaw

County council is planning to take its time to "get it right" on a draft shoreline preservation bylaw after concerned associations overflowed its chambers Feb.

The Coalition of Haliburton Property Owners' Associations (CHA) and the

Haliburton County Home Builders Association (HCHBA) came out in force for their respective delegations to council on the draft bylaw, which would restrict development and activity within 30 metres of shorelines. Council voted to undertake another line-by-line review of the bylaw, engage citizens online and in public

meetings, as well as consider a working committee or group to guide the process.

With more than 40 people in the room, County Warden Liz Danielsen said it was the fullest she could recall council chambers ever being in the past decade. She said although it was initially hoped the bylaw could be finished before the summer, it

is clear consultations would have to last longer than that based on input.

"We acknowledge that there's urgency there, but we also have to get it right," she

The bylaw disallows any removal, destruction or injury to natural vegetation within the 30-metre buffer zone, unless the See "Builders" on page 2

# Smokehouse fired up over fine

Norman Weber of Norm's Smokehouse in Gelert doesn't mince words in speaking about the unfairness he sees in his recent conviction for operating a meat plant without a licence.

The Ministry of Agriculture, Food and Rural Affairs (OMAFRA) put out a press release Feb. 27. They said investigators had also discovered that Weber had been supplying a local business with uninspected meat products. He'll pay a total of \$7,500 in fines after facing Minden Court Feb. 11.

"In September 2019, a Compliance and Advisory Officer and a local Health Inspector visited the store for a follow-up inspection and found that Mr. Weber had been producing several smoked and cured meat products without the required license to do so," OMAFRA said.

They added it was his third conviction for offences under this regulation.

Weber told *The Highlander* in an interview he'd gotten out of the smoked meat business following his second conviction a couple of years ago. He said to make smoked meat, such as pepperettes, jerky, salami or sausages, plants require a category two meat license. He no longer had one.

At the end of last summer, before getting busy with wild game and fish,

he said he took the opportunity to make some smoked meat for himself and his family.

He said he had a substantial amount in the shop when a compliance officer made a surprise visit Sept. 10.

"They find me with category two products in my cooler. Bam, Bob's your uncle. How do I argue that?" He said he had no way of proving the smoked meats were for family so pleaded guilty for the sake of expediency.

He said his first conviction, which he calls the "salami caper," in 2016, occurred after he was required to send his recipes to OMAFRA but did not hear back from them and went ahead and made five salamis.

Strike two came a couple of years after that. Weber takes full responsibility, saying, "stupid me, I was cheating a bit." He said he had some pepperettes and jerky in his display cabinet when there was a surprise visit in 2018. He was fined \$3,000 plus court costs.

Through it all, Weber maintains there has never been anything wrong with the actual meat, "always the issues were paperwork, bureaucracy, stuff like that."

He said at one point, he had 12 different clipboards on the walls that had to be filled out on a daily basis. He added inspectors came every two weeks to check the "reams and reams of paperwork involved. Every step

of every process you have to write down." He said he got into trouble for things such as not having all the clipboards filled out, a little bit of light coming under the door or light bulbs not being strong enough in the cooler.

He estimates inspectors used to spend about \$1,000 a day to come to Gelert to check up on him, and believes OMAFRA issued the press release about his conviction and fine to justify their existence.

Today, he still does wild game and fish but no longer sells meats. There's a sign in his shop that says he's been regulated out of existence.

However, OMAFRA said in the release that Ontario is a leader in food safety and meat inspection. They said the province's Food Safety and Quality Act, 2001 and its regulations are part of Ontario's food safety system and set high standards for the protection of consumers and the welfare of food animals.

# Builders want more moderate bylaw

Continued from page 1 activity is under an exemption or a permit is granted.

CHA board chair Paul MacInnes detailed the science of how the natural vegetation is vital to lake health by helping prevent contaminants from getting into the water. Failing to protect lake health leads to algae blooms, which can plummet property values, he said.

"There will be costs to this bylaw, absolutely," MacInnes said. "But it's our belief that the costs of this bylaw will pale, absolutely pale, in comparison to the costs if we don't protect our lakes."

HCHBA vice president Glenn Evans said his association is not adversarial to the CHA's position. He said the bylaw needs to be more moderate in its limitations on shoreline development than it is currently. He added properties that harm shoreline vegetation before the bylaw is in place need to take some responsibility too.

"We believe that we can work together to protect our lakes. We believe there is room for mechanisms, policies to be put in place," he said. "But we feel the bylaw is a little bit far-reaching."

Council discussed options for public consultation and the need to start meetings before the busy summer season. The County has conducted an online survey on the bylaw which attracted hundreds of responses, though Coun. Carol Moffatt said many

did not know of it.

However, Danielsen said the bylaw should not have been too surprising, given it was a subject in 26 different municipal meetings throughout the County and lower tiers and had multiple newspaper articles about it.

"For anyone to suggest that we've been working under cloak of darkness and we haven't been trying to get the message out is not fair," she said.

Danielsen said council also needs to sort out the costs of making the bylaw possible. The County has set aside \$50,000 in this year's budget as start-up funding for the bylaw.

"There is going to be a rather extraordinary cost, because I'm not interested in us developing a bylaw we can't enforce or manage," she said.

# Services delivery review awarded

The County of Haliburton has awarded a tender to Toronto-based Strategy Corp. for \$219,000 - to help complete a service delivery review.

County council voted for the company's submission Feb. 26. It was one of eight received. The proposal is part of the County's efforts to explore governance changes.

Proposals ranged between \$64,800 and \$224,000, according to CAO Mike Rutter. He argued Strategy Corp. is well qualified and emphasized the importance of the project in justifying the higher cost. The project was initially budgeted at \$150,000.

"This informs a really big conversation about governance and service delivery," Rutter said. "Sets the County up for the next 25-40 years."

However, the municipality is receiving an additional \$150,000 in modernization funding from the province, which it will use to offset costs to lower-tier municipal partners, Rutter said.

He further stressed the review would not directly address the question of governance change, which council would have to decide afterwards.

The project is expected to be completed by June 12.

# **Tourism committee** may get overhaul

County council is considering making an application-based process for general public tourism committee members after the controversy posed by TripAdvisor marketing.

The committee currently has three public appointees, chosen by the tourism stakeholder group. But Coun. Carol Moffatt said she is concerned by the division in the tourism sector and wants to ensure there is more broad representation.

The committee is embroiled on whether to spend marketing dollars on TripAdvisor.

Some accommodators have expressed concern about TripAdvisor's influence, and Warden Liz Danielsen commented there is some division between them and the tourism stakeholders' group.

No resolution came forward, but council members spoke favourably to Moffatt's idea. She said if the committee is dissolved or restructured, current public members could reapply.

"We try to ensure that broader representation for the entire community," Moffatt said. "We have seen it's not happening."

# Cell project moving at 'lightning speed'

Coun. Brent Devolin is asking for patience as the \$213 million Eastern Ontario Regional Network (EORN) mobile broadband project progresses behind the

Councillors pressed Devolin, an EORN board member, for news on the project. After years on the shelf, the project finally received the federal funding it needed to move ahead last July. The project will help improve cellular coverage in eastern Ontario.

Devolin said he could not comment much on what is happening, but said progress is being made and he expects more public news later in the year. Rutter said EORN is close to finalizing a transfer payment agreement with upper levels of government and hopes to release a request for proposals shortly after that, though added it would take months to review submissions.

Devolin said the project is complicated but is moving quickly relative to its scale.

"A quarter-billion-dollar project, with how many stakeholders and levels of government, people need to understand, this (procurement) is going to happen within a year. This is lightning speed," Devolin said.

He further said construction is going to take four or five years, once EORN finishes procurement. (County of Haliburton news compiled by Joseph Quigley).

# Minden sets 'aspirational' climate charge targets

Minden Hills councillors passed Greenhouse gas emissions (GHG) targets at their Feb. 27 meeting.

They are a 20 per cent reduction in buildings, 10 per cent for fleet and 10 per cent for waste by 2030. Council resolved to review yearly targets.

County planner Charlsey White and climate change coordinator Korey McKay spoke at the meeting.

McKay broke down Minden's current GHG inventory. The bulk comes from waste, at 81 per cent, then fleet (12 per cent) and buildings (six per cent).

She said the key to reducing waste GHG is education and initiatives to cut what goes into landfills and diverting waste; exploring the opportunity for larger changes; and improving data.

With fleet, it's about anti-idling potential and introducing some hybrid and electric vehicles.

As for building, McKay said the old community centre accounted for 28 per cent of emissions.

During a short discussion, Coun. Bob Carter said the township should be setting aspirational goals. "We must try to reach it. If we make it, great. If we fail, it's at least something to aspire to."

Coun. Pam Sayne said the township hired a consultant to do a building efficiency report and she wanted that now to be put

into practice, saying it's the key for the township right now. She added when it comes to fleet, technology is changing very quickly. She also raised the issue of a composting program, noting it had been talked about at the township but never put into place. She'd like to see the township move in that direction.

McKay said methane gas at landfills is a big emitter of GHG.

Coun. Jean Neville said municipalities should ease laws around backyard chickens. "People are all hung up on disease for some unknown reason." She said supplying compost to animals would largely eliminate the problem.

Mayor Brent Devolin added, "we're not interested in setting targets where we don't even break a sweat. The elephant in the room is landfills. The waste part is the most complex part and the one we know the least about."

He queried whether they should set higher targets. However, Carter said he did not feel it was right for council to arbitrarily establish targets, when White and McKay had done the research. He wondered about delaying for 12 months and going back to Minden's climate change action committee.

McKay acknowledged the waste data was not as good as for buildings and fleet. However, she said once they get more specific data, such as future diversion rates, they can adjust the 10 per cent figure. "Start at 10 per cent, then refine."

Sayne said she wanted to affirm targets on the day and not defer.

Director of public works Travis Wilson

said later in the meeting that his department was working on a small-scale waste audit and he would report back to council.





# Resident pleads for Minden to protect heritage buildings

Elizabeth Turner dons a pair of wooden snowshoes and begins trekking on her property on Soyers Lake Road. As she heads for the lake, there is a demolished building to the right - the excavator that brought it to the ground still onsite.

Looking at the ruins at 1942 Soyers Lake Rd., she remembers the building's past. It was built by her great-grandfather Joseph Dummitt in 1891. It was a lodge beginning in the 1920s until the 1970s. She lived in the farmhouse until going to university.

While she feels a personal loss, she thinks Minden residents need to know the building's wider significance and why she is devastated council was unable to have it designated under the Ontario Heritage Act before its recent demolition.

"The development of the property reflects the development of the municipality from farming and logging to the beginning of the tourist industry," she said.

She noted the gothic farmhouse was typical for pioneers of the day and the only example on Soyers Lake. Dummitt farmed dairy and beef cattle. The kitchen hosted square dances. For a half-century it was the Lakeview Lodge. The Soyers Lake Ratepayers Association held their early meetings

"So, the house has significance, not only to me and my family but to the whole lake community. I met a cottager vesterday who was shocked when he saw the demolition as he drove to his cottage from the city. He had always assumed that the house was a protected historic site and was shaken to think it is gone. A landmark on the lake is gone."

When she got wind of a possible demolition by the property's new owners, Turner had hoped to save the farmhouse from the wrecker's ball via council designating it under the Ontario Heritage Act. However, as she told Minden Hills staff and councillors Feb. 27, she was too late and believes a lack of communication at the township on the file has dealt a "significant blow to local history."

She noted that under the Act, council is allowed to make decisions regarding heritage properties, including to designate. She added they have to fulfill one criteria outlined in Ontario Regulation 9/06.

"1942 Soyers Lake Road clearly fulfills multiple criteria under Regulation 9/06 and is eligible for designation," she said.

She further noted that Ontario municipalities are required to protect their heritage resources and there are policies regarding cultural heritage preservation in the Minden Hills and County of Haliburton official plans.

She said she first raised the issue with a councillor in July 2019, and was referred to the planning department. She met with them last October and it was recommended she speak to council. She was originally to appear in January but was away and did not anticipate a winter demolition.

While waiting for the February delegation, staff issued a demolition

"By issuing the demolition permit prior to council receiving the delegation and making a decision, staff undermined council's ability to fulfill their provincially-mandated responsibility to make decisions regarding historic properties within the municipality," she told council.

She doesn't think it was in any way malicious, just a "troubling lack of communication among those involved in this file and an insufficient understanding of provincial planning legislation and policy."

She said she hopes the township learns from the experience, since there are many important historic properties not now recognized or protected.

"If Minden Hills is going to remain the special place that it is with a rich and interesting history that is enjoyed by residents and visitors alike, the protection of historically significant buildings is something the municipality must begin to undertake," she said.

Mayor Brent Devolin said, "council is seeing this today for the very first time," and has asked for a staff report. He said Turner had given them food for thought and expressed an interest in council taking a more proactive role in future.

After the meeting, Coun. Jennifer Hughey, who first spoke to Turner last July said via email, "It's very unfortunate how circumstances transpired in this case, but a delegation is always the best way to present concerns to council as a whole. I commend Ms. Turner for bringing to light the way Minden Hills could work to conserve, protect and enhance the cultural heritage of the municipality through designation considerations in the future."

Planner Ian Clendening, who spoke to Turner last October, added, "at this time staff will be preparing a report to council regarding heritage designations."

The Highlander was unable to reach the owners of 1942 Soyers Lake Rd. for comment.

# Loss of a landmark

Historic properties tell the story of our community.

They help maintain the character of local places.

They provide a sense of identity.

These aren't my words, although I do agree with them. They were spoken by Elizabeth Turner, a woman who made an emotional delegation to Minden Hills council Feb. 27.

She talked about a missed opportunity to designate a building at 1942 Soyers Lake Rd. under the Ontario Heritage Act.

Through a series of apparent miscommunications, the building is now demolished.

It all started when Turner caught wind that the owners were seeking approval to demolish the structure. She went to Coun. Jennifer Hughey last July to see what could be done. She then met with planner Ian Clendening in October. Both Hughey and Clendening told her to make a delegation to council. There was absolutely nothing wrong with that advice.

What went horribly wrong was by the time Turner made her delegation last Thursday, the building had already been razed. The other hitch was Turner may have made her pitch in January but was out of town. However, she never anticipated a winter demolition. Somewhere along the

way, the demolition permit was granted and the owners notified.

Councillors, other than Hughey, only learned of the building's historic and social significance after the fact. They never got an opportunity to discuss whether they should pursue a designation under the act.

The case for one was arguably strong.

After all, the house was a really good example of a gothic farmhouse, typical after pioneers decided to permanently put down

Builder Joseph Dummitt later transferred it to Rizpah Dummitt and her husband Edward Elstone, who farmed but saw a tourism potential. They started out renting rooms to hunters and then summer guests. Before long the demand required cottages be built. Lakeview Lodge was born. Many stayed there while building their own cottages in the area. The lodge was where mail was dropped off and picked up, and phone calls made and received. In 1975, the lodge was transformed into housekeeping cottages and the house returned to being a private dwelling.

wanting to demolish a building in the hopes of erecting a new one. They likely didn't know the depth of the building's history. How could they? It was not designated.

We take no umbrage with private owners

Nor would a designation have stopped

them completely. They may, however, have had to alter their plans to ensure some features were kept intact.

Any council in Ontario can apply under Regulation 9/06 of the Act to get

designation. Indeed, they are encouraged to via the province and their own official

We may never find out what exactly happened with this file although council has requested a staff report. As Mrs. Turner has stated, she doesn't think there was malice involved, simply a lack of communication.

She hopes the township learns from this, and quite frankly, so do we.

It is important to protect heritage buildings and properties in the Highlands. There is a wealth of knowledge that can be tapped into, whether it is the Haliburton County Heritage Society, the museums, or longtime residents. A list should be struck now so we don't lose lodges or other important remnants from our past. It isn't about stopping development of the new but protecting the old so we can indeed tell the story of our community, maintain the character of our local places and provide ourselves with a sense of identity.

# **LETTERS** Bylaw needs revising

\* Editor's note: The original letter, published Feb. 27, was edited for length. The letter writer felt all of her points were therefore not expressed. She also felt the title - "Against shoreline preservation bylaw" was inaccurate.

### Dear editor,

Boshkung Tree Service is not opposed to a shoreline preservation bylaw. However, it is our opinion that the proposed bylaw, as written, requires revisions and retractions.

We believe a big issue is the restrictions on landscaping and building projects taking place within the 30m zone, inland, from the high watermark.

In CHA's video series, Aquatic Ecologist, Barb Elliot states the shoreline as being "the transition zone between the land and the water." Also stating "what you really need is the riparian buffer zone between the land and water," that being a minimum of 3m.

We believe that CHA's shoreline stewardship approach of protecting the waterways, combined with the current County Shoreline Tree Preservation Bylaw (which already prevents clear cuts back to 30m) seems like a feasible method to preserve and protect our shorelines/ waterways.

No one really can dispute the overall intent of the bylaw, however a balance of good intentions for the community needs to be kept in mind. County councillors themselves have been quoted saying "there is going to be a rather extraordinary cost" and that they need to take the time to "get it right." The analogy of "don't bite off more than you can chew" seems quite fitting. Let's focus on doing fewer things

well rather than developing a bylaw that is unenforceable or impossible to manage.

The ripple effect also needs to be considered. The amount of tax dollars, use and enjoyment of waterways, economic viability of our community and sustainability are equally important for today and tomorrow. We need a workable solution that both protects our lakes and our economy. We encourage everyone to do your research, stay informed and share concerns with your councillors.

# Strengthen shoreline bylaw together

Dear editor,

The letter from Michele Bromley and John Fedeski of Boshkung Tree Service entitled "Against Shoreline Preservation Bylaw" in the Feb. 27 *Highlander* claims that the proposed bylaw is ... " Harsh, unnecessary and an extreme overkill."

They correctly point to phosphorus and a long list of other contaminants, including road salt, as being key threats to lake water quality but then go on to claim that the proposed bylaw would have no impact on any of those substances actually getting into our lakes. They could not be more mistaken.

Natural shorelines are the most effective means of protecting lake water quality precisely because native plants intercept the phosphorus leaching from even wellfunctioning septic systems as well as the road salt and other pollutants caught up in storm water runoff.

According to the "Love Your Lake" shoreline evaluation of over 12,000 individual shoreline properties across 60 Haliburton lakes, undertaken by the Coalition of Haliburton Property Owners' Associations (the CHA) between 2014 and 2018, there are 5,228 shoreline properties in need of restoration back toward the 75 per cent natural standard. The business opportunity this represents is estimated to be in the neighbourhood of \$25 million.

Our collective past practices, including those of the landscape industry, have contributed to a transformation of natural shorelines into artificial environments with lots of hardened surfaces and much less natural plant cover. A truly sustainable future lies in protecting our remaining natural shoreline and restoring what's been overly developed closer to the 75 per cent natural level.

Besides being the right thing to do, there's a huge economic opportunity for the landscape industry in helping do that work if they choose to embrace it.

The proposed bylaw is a good first step forward but it is not without its shortcomings, including the proposed exemptions for municipalities and other public agencies doing shoreline work about which Bromley and Fedeski rightly complain.

But rather than throwing the baby out with the bath water, a much more environmentally responsible way forward would be for the landscape industry to join forces with groups like the CHA to support a more sustainable future by strengthening, not undermining, the proposed bylaw.

# Health agencies ready for Coronavirus

Local health agencies are continuing to prepare for any cases of the internationallyspreading Coronavirus, although the risk of contracting it remains low in Ontario.

Area health agencies, including the Haliburton Kawartha Pine Ridge District Health Unit (HKPR) and Haliburton Highlands Health Services (HHHS), are working together to share information, keep up to date and have protocols in place should the respiratory virus, technically known as COVID-19, develop locally. In a March 2 press release, agencies said the health unit is ensuring active screening protocols and proper protective equipment are in place.

"There have been a number of improvements made in the way we prepare for wide-spread illnesses since we experienced SARS (another respiratory virus which broke out in 2002)," HKPR District Health Unit medical officer of health Dr. Lynn Noseworthy said. "The bottom line is that we are prepared for if, and when, we may see a case locally."


However, the Public Health Agency of Canada has said the risk remains low for Canadians as of March 4. As of March 3, 33 cases have been confirmed across the country, including 20 in Ontario.

Other seasonal respiratory illnesses are also circulating, Noseworthy said. However, health agencies said in a press release that most people who get the virus only experience mild symptoms.

"The risk of serious illness appears to rise with age and the presence of other complicating factors. People who have died from the virus in other countries have tended to be older and have had multiple health issues that weakened their immune systems and put them at greater risk," the press release said.

But jurisdictions are taking extra precautions. Ontario announced an enhanced response structure March 2 to "review, strengthen and implement provincial and regional plans and ensure their responsiveness to the specifics of COVID-19."

Local health agencies offer the usual tips to avoid the spread of sickness and remain healthy, including washing hands frequently and thoroughly, covering the mouth and nose when coughing or sneezing, getting your flu shot and staying home if you or a

family member are ill.

If you develop symptoms such as a cough or fever and have visited an affected area in the last 14 days or had close contact with someone under investigation or confirmed with COVID-19, call your local health care provider.

# Health unit tells county it can't budge on bigger bill

County of Haliburton councillors are upset with the province about getting pushed to pay 10 per cent more into the local health unit.

Council discussed the dispute Feb. 26. The Haliburton, Kawartha Lakes, Pine Ridge (HKPR) District Health Unit has asked municipalities to increase funding by 10 per cent over last year, due to formula changes imposed by the province. For the County, that's an extra \$42,137 compared to 2019, yet to be released by council.

County council requested more information about any discretionary spending from the unit. Rutter reported the health unit said everything it is spending is mandated.

"Taxation by stealth," Coun. Carol Moffatt said. "The provincial government makes changes to a body that has the mandate to just ask for a certain amount of money and there's no discussion."

The province is shifting the provincialmunicipal split for health units from 75-25 to 70-30. Certain programs once funded 100 per cent by the province now require municipal contribution.

The City of Kawartha Lakes is also reluctant to release funding, with its council voting not to provide the extra \$185,912 it's been billed for.

Ministry of Health and Long-Term Care spokesperson David Jensen said costsharing was kept the same last year to "provide municipalities with additional time to find efficiencies." A 10 per cent cap was instituted for this year's increases to ease transition, he said.

The province is consulting with partners about health unit changes, including consolidation. Board of health chair

Doug Elmslie, a City of Kawartha Lakes councillor, said the board made its concerns about changes known at a consultation session in Peterborough Dec. 19.

"We're pitting our partner municipalities against the health unit that is trying to work for their benefit," Elmslie said. "It makes it very uncomfortable for the councillors and the elected officials who sit on the board."

He added he is hopeful the consultation report would lead to a solution. But the health unit needs the extra municipal funding to be released.

"We are still mandated by the province to provide the services for the programs that we have," he said. "But at some point during this year the money is going to run

When asked whether the province is open to reversing its funding decisions based on feedback, Jensen said "our government is committed to working with our partners to modernize public health services. We are making changes to ensure that public health units are sustainably funded and better positioned to support the needs of people."

He added municipalities are obligated under the Health Protection and Promotion Act to pay unit expenses.

Deputy warden Andrea Roberts, also a board member, said the unit has worked to cut costs as much as possible.

"I've seen them make changes in staffing, I've seen them make changes in operational, organizational things that have been very effective," Roberts said.

Coun. Brent Devolin said municipalities do not get enough say about the funding.

"They spend our money without any checks and balances," Devolin said. "Don't go through the charade of having us involved."



# Economic development committee disbanded

Dysart's economic development committee is no more, and the municipality is not planning to continue its work on short-term rentals, Mayor Andrea Roberts said.

The committee was officially dissolved this month, announced during the council meeting Feb. 25. It first met in January last year, but Roberts said the committee had issues with holding meetings due to lack of quorum

Roberts said council members feel a task force should work better for economic development.

"We have the economic development strategy and many of those things are being worked on," Roberts said. "We will continue to use that document and create ad hoc groups as needed."

At its first meeting, economic development committee members decided to focus on creating short-term rental regulations for the municipality.

But Roberts said that is not something Dysart wants to tackle, and other bylaws should work to address most concerns. "The short-term rental issue just went around in circles and I think until another municipality of our size gets something in place and proves it's working, nothing will happen in Dysart," Roberts said. "Most of the concerns were around noise, septic overuse, fireworks, etcetera, and we have bylaws in place for those."

# Waste emission targets set at 80 per cent

Dysart et al set its greenhouse gas reduction targets at 80 per cent for its waste sector, 10 per cent for its vehicle fleet and 20 per cent for its buildings.

# Dysart et al news

County climate change coordinator Korey McKay presented to council Feb. 25 and recommended the targets for 2030, which are from a 2018 emissions baseline. The municipality produced 4,623 tonnes of carbon dioxide equivalent that year, according to McKay.

McKay said the waste sector reduction target – which makes up 86 per cent of the overall municipal emissions - will be significantly helped by landfills closing and becoming transfer stations, meaning their emissions will not be part of the municipality's inventory. However, councillors pointed out trucking the waste elsewhere will have an impact.

"The amount of emissions from the trucking of vehicles back and forth is still less than having the waste of your site decomposing and having the methane and other gases coming out," County director of planning Charsley White said. "Not saying it's better."

Deputy Mayor Patrick Kennedy questioned how achievable the vehicle emissions targets would be given the size of the roads network, but McKay and White said technological advancement in the next decade should help make it possible.

"You'd be amazed by the progress I think we can make there," White said.

# \$75,000 for service delivery review

Dysart et al has received a \$75,000 grant from the province to do a service delivery and modernization review.

The review is separate from the one being undertaken at the County level and aims to find more efficiencies for the municipality.

The municipality has released a request for proposals, with a March 18 submission deadline. (*Dysart et al news compiled by Joseph Quigley*).





# Unseasonably good winter trail season

Despite uneven weather conditions, many winter trail operators report steady or increased permit sales and trail use as spring approaches.

The Haliburton County Snowmobile Association maintains 370 kilometres of trails across the county. Permit sales are running steady with earlier years, at about 2,300 in the face of difficult conditions for this activity, according to John Enright, HCSA director responsible for marketing.

"Last winter was 'snowmageddon', this winter below average," said Enright via email

"It's just like going to the casino, you are not dealt the best hand, but you have to play it anyway."

Haliburton Highlands Nordic Ski Association president Thom Lambert reported "a very successful" season to date on the HHNTA's 36 kilometres of trails, with estimated sales of just under 1,000 permits.

"We have surpassed our 2018/2019 number, both [in dollars] collected and number of skiers, already and we still have March ahead of us," said Lambert via email.

The Frost Centre in Algonquin Highlands

features 21 kilometres of by-permit Nordic ski trails and 38 kilometres of by-donation snowshoe trails, with equipment rentals for both sports, and backcountry camping.

"The temperature swings and lack of snow early in the season made it difficult to maintain consistency on the trail base, which was most of January," sad Chris Card, the township's parks, recreation and trails manager, via email.

"February has been fantastic and we anticipate some great late-season skiing."

Permit sales have been equal to last season's, although "interestingly we have had a higher number of youth and seniors skiing this year," said Card.

Sir Sam's Ski/Ride operates 14 alpine ski and snowboard runs and a snowshoe trail in Haliburton.

Weather conditions have been "certainly warmer than last year with up and down temperatures but generally [it's been] an average winter for weather," and trail conditions have been the "best in years," said owner Chris Bishop via email.

Permit sales are up by five per cent over last year and "should end up 10 per cent [over] on skier visits," Bishop added.

This season saw a new use for trails as the county's tourism department mounted a winter version of Hike Haliburton, hosting snowshoers on several systems. The event drew 380 participants, 40 per cent of whom were visitors, according to Amanda Virtanen, county tourism director. Many hikes were over-subscribed.

"We are hearing from local retailers that the demand for snowshoes is high – and from experience providers that snowshoeing expeditions are sought-after," said Virtanen via email. "It's an easy activity that most anyone can participate in, with little investment."

An event report is slated for mid-March. Trail systems close for winter use when conditions can no longer support that, but several systems also operate from spring through fall.

For example, at the Frost Centre, the Nordic trails will close and the snowshoe trails will become hiking trails and gateways to canoe routes and summer backcountry camping.

Sir Sam's will switch gears to downhill and cross-country mountain biking and interpretive five-kilometre hiking. They'll even mark the changeover with Spring Splash, where competitors ski over open water, and the Slush Fest – Fat Bike Festival.

But if you prefer winter sports, never fear – come the fall, winter trail operators will be joining you to watch for snow.



# Who should be my Power of Attorney for Property?

Every adult should have a power of attorney for property. It's a document that gives another person legal authority to deal with your bank accounts, investments, real estate – almost anything you can do with a signature.

A power of attorney can be used in two situations: with your permission, for example if you are going on a long trip and need someone to sign cheques for you; or if you become incapacitated. Either situation can be temporary or permanent.

Most married and common law couples name each other as attorney, which makes sense for a lot of reasons. Having made a life together, couples generally know what each partner expects, and their interests are usually similar. Hopefully they also trust each other with money and other important matters.

However as couples grow older together, they may also decline

in their abilities. If one partner is experiencing age-related decline or illness, the other, also likely elderly, may not be up to the task of managing How many children do you have? everything.

It's important therefore to have an alternate attorney. It should be someone trustworthy, reliable, reasonably good with money and likely to be available when needed. Usually, people will name an adult child to be their main or alternate attorney. But it's worth considering a few issues before making that decision.

### Is your attorney also a main beneficiary under your will?

An attorney's responsibilities may include making financial and living arrangements for you, and there's a bit of a conflict if your attorney is also a main beneficiary. What they spend on your housing and other needs is likely to reduce their future inheritance, so you want to be sure

your attorney will not scrimp on your care to benefit themselves.

If you have more than one child, sibling rivalry is something to consider. Putting one adult child in charge of your affairs can cause conflict with the others; making them all attorneys can create other kinds of conflict.

# Are they really up to it?

Being someone's attorney can sometimes be a major pain. Think paperwork – lots of it – and many trips to banks and post offices. You want to choose someone with a bit of grit, someone who can still take care of things even when they're busy

For these reasons, often a friend, brother or sister is the best choice of attorney, but it's a lot to ask. Attorneys can be paid, but most friends and siblings aren't looking for compensation. Ideally you're looking

for a someone you feel close enough to that you would do the same for them.

A power of attorney is one of the three documents every adult should have; the other two are a will and a power of attorney for health care. In my practice, we talk about many of the above issues to ensure that we have the right people named in your planning documents, so that when the time comes, your affairs are being managed by people you trust who can be relied upon to fulfill your wishes.




